



## **SOCERCITY – EPIC FAMILY AGREEMENT**

*Contractual agreement in regard to funds for Lil Kickers classes, house teams, and SoccerCity camps*

By signing this for yourself and in representation for / regards to the children / minors you are registering, you understand and agree with all that is listed below:

1. I agree that I have the correct amount of funds in my Epic tuition account to pay for the current program(s) I am enrolling in. In the event that I do not have sufficient funds in my Epic tuition account, I give SoccerCity consent to charge my card with the remaining amount due. (You have 7 days from notification of lack of funds to provide another form of payment before we will charge your card). If I cancel my card, have my bank refute the charges, or the card has insufficient funds to cover any remaining balance from Epic tuition, I will not be allowed to enroll in any of SoccerCity's youth programs for any of my family or minors in my care until the dues have been paid.
2. I understand that by registering in the current program(s) that my Epic tuition, once applied, will not be refunded back to me, or applied to a future season or a different player for any reason whatsoever. If the player in question attended at least one class (free trial notwithstanding) I will be charged for the prorated amount of the season remaining from when I registered, even if the amount reflects a number of classes I agreed to but was unable to attend. (Lil Kickers and house teams are seasonal, while SoccerCity camps are weekly- Epic only pays invoices monthly.)
3. I acknowledge that if I decide to personally pay for the full dues of the program(s) I am enrolling for, that if Epic does not reimburse SoccerCity fully due to lack of funds or issues with your account, that I may not be refunded in full or at all. \*\*\*Camp customers MUST pay for the fee up front and will be reimbursed when Epic pays SoccerCity.\*\*\*
4. Epic does not pay for memberships, so for Lil Kickers I must pay with card upon registration for my player(s) annual individual or family membership. In this instance, I give SoccerCity permission to save my card in their database to charge if my Epic tuition is insufficient or there is an issue with my account (see #2).
5. Epic does not pay for Summer programs after May 31<sup>st</sup>, so all registrations for Summer classes, teams, and camps must be done prior to that date in order to receive Epic tuition for it. To receive tuition towards a Summer program, you must be re-enrolled in the upcoming scholastic year. Epic also does not pay for Fall programs until the start of September.
6. I agree to contact Epic, as SoccerCity will not be able to help, with any issues in regard to their invoicing policies or my account, specifically in regard to funds for program tuition.
